Note:-

1. School fees can be paid in two installments. **The 1st installment of the school fee will be paid latest by April 30th, 2024 and the 2nd installment of the fee is to be paid by Oct. 31st, 2024.** If the fee is not paid on or before the due date, a late penalty of Rs. 5/- per day will be charged. However, if the school fee is not paid within the 15 days from the last date, the school reserves the right to struck off the name of the students.

2. Transport fees can be paid in two installments. The 1st installment of the transport fee will be paid at the time of start of conveyance facility, the 2nd installment of the transport fee is to be paid by Oct. 31st, 2024. If the transport fee is not paid on or before the due date, a late penalty of Rs. 5/- per day will be charged. However, if the transport fee is not paid within the 15 days from the last date, the school reserves the right to stop the conveyance facility of the students.

3. No student will be allowed to sit in the classroom until the 1st installment of the school fee is paid. Similarly, the conveyance facility will be made available only after the deposition of prescribed charges.

4. One month notice is required for the withdrawal of school conveyance facility or one month conveyance charge in lieu thereof.

5. Fees will be accepted only through Cash or by Demand Draft / Cheque in favour Smt. Godavaribai Ramdeo Podar Sr. Sec. School. Defaulting cheque will be fined Rs. 500/-

6. Parents are requested to take the receipt for the payment made by them from the school office failing which Management of the school will not be responsible.

7. The Old / Existing students will be required to deposit the fee by May 15th, 2024 failing which their name may be struck off.

8. Rebate of Rs. 2000/- on school fees and Rs. 1000/- on transport fees can be given to new admissions, if they pay one time fees within 7 days of joining school or admission.

9. For class 11th rebate of Rs. 2000/- on one time deposit of school fees and Rs. 1000/-on one time deposit of transport fees may be given upto July 15th, 2024.

(I) 20% in school fees will be allowed to those applicants who have secured 90% or more marks in CBSE / RBSE Board Examination of class 10th.

(II) 15% in school fees will be allowed to those applicants who have secured 85% or more marks in CBSE / RBSE Board Examination of class 10th.

(III) 10% in school fees will be allowed to those applicants who have secured 75% or more marks in CBSE / RBSE Board Examination of class 10th.
